COUNTY MANAGER'S RECOMMENDATION OR COMMENTS: Recommend Approval

SUMMARY OF INFORMATION:

Each year, the North Carolina 911 Board makes funds available through a competitive grant process established pursuant to N.C.G.S.143B-1407. The primary purpose of this grant program is to financially assist eligible Primary Public Safety Answering Points (PSAPs) in rural and high-cost areas of North Carolina.

There are three (3) types of grant programs available:

- 1) Consolidation
- 2) Individual PSAP Enhancement/Replacement
- 3) Regional Initiative Enhancement/Replacement

Forsyth County applied for a consolidation grant totaling \$2,170,000 for its Phase I Primary PSAP Consolidation Project. On August 30, 2016, the County received notification that the grant request was partially funded at \$1,085,000.

A condition of the grant award includes explaining how the project will be accomplished as described in the grant application with the reduced amount. Currently, staff is determining the impact of the reduced award on the Phase I Primary PSAP Consolidation project completion.

While construction costs at the Public Safety Center were included in the grant request, these costs were also included in the contract between Forsyth County and Landmark Builders of the Triad as part of the Public Safety Center - Probation & Parole, Emergency Operations Center, and 911 Call Center Project. Therefore, the reduced grant funding will allow the County to up-fit the new space through upgrading and reconfiguring the telephone system and purchasing consoles, servers, and other audiovisual equipment and supplies after complying with applicable bidding laws. Other project needs and costs are being examined as well to determine what can and cannot be done within the reduced grant award.

The purpose of this item is to receive authorization to execute necessary documents to receive the reduced 911 grant funds and to amend the Emergency Telephone System Special Revenue Fund to appropriate the grant proceeds.

WHEREAS, the Forsyth County Emergency Services Department applied for grant funding totaling \$2,170,000 for a Phase I Primary PSAP Consolidation Project; and

WHEREAS, on August 30, 2016, Forsyth County received notice that it was awarded a reduced grant amount of \$1,085,000; and

WHEREAS, a condition of the grant award is providing an explanation of how the project will be accomplished as described in the grant application with the reduced funding;

NOW THEREFORE BE IT RESOLVED that the Forsyth County Board of Commissioners hereby authorizes the County Manager and Clerk to the Board to execute, on behalf of Forsyth County, the necessary documents to receive grant funds from the North Carolina 911 Board for the Forsyth County Phase I Primary Public Safety Answering Point (PSAP) Consolidation Project, subject to a pre-audit certificate thereon, by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.
