

**RESOLUTION AUTHORIZING EXECUTION OF A SOFTWARE SERVICE AND
SUBSCRIPTION AGREEMENT BETWEEN FORSYTH COUNTY AND SHI
INTERNATIONAL CORP. TO PROVIDE DATACENTER, E-MAIL, WORD
PROCESSING AND DATA COLLABORATION SOLUTIONS
(MANAGEMENT INFORMATION SERVICES)**

WHEREAS Forsyth County maintains a Microsoft Enterprise Agreement for subscription and software services for Microsoft products and services and proposals were solicited and received for comparable e-mail, word processing, and data collaboration solutions;

WHEREAS in prior years the Forsyth County Sheriff's Office also maintained a separate Microsoft Enterprise Agreement for subscription and software services for Microsoft products and services;

WHEREAS N.C.G.S. 143-129(e)(7) authorizes Forsyth County to make purchases of information technology through contracts established by the Department of Information Technology as provided in Article 15 of Chapter 143B of the General Statutes;

WHEREAS it is the recommendation of the County Manager, the Chief Technology Officer, and the Sheriff's IT Manager to realize the efficiencies of consolidating the Microsoft Enterprise Agreement for subscription and software services for Microsoft products and services;

WHEREAS, pursuant to the terms of the State contract, the North Carolina Department of Information Technology has awarded the State contract for the provision of Microsoft subscription and software services to SHI International Corp.;

WHEREAS SHI International Corp. can provide Forsyth County such services as set forth in Attachment A attached hereto and incorporated herein by reference; and

WHEREAS it is the recommendation of the County Manager, the Chief Technology Officer, and the Sheriff's IT Manager, that a contract be awarded to SHI International Corp. for a consolidated three-year term Microsoft Enterprise Agreement for Datacenter, E-Mail, and Data Collaboration Solutions in an annual amount not to exceed \$544,192.82 to provide the services set forth in Attachment A;

NOW, THEREFORE, BE IT RESOLVED, that the Forsyth County Board of Commissioners hereby authorizes the County Manager and Clerk to the Board to execute, on behalf of Forsyth County, a contract with SHI International Corp. for consolidated Microsoft Enterprise Agreement subscription services, at such rates set forth in the North Carolina Department of Information Technology contract, for a three-year term at an annual cost not to exceed \$544,192.82, with options to renew the contract for two subsequent one-year terms, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney; and

BE IT FURTHER RESOLVED, that the County Manager is hereby authorized to amend such contract within budgeted appropriations for the duration of the contract.
