WHEEPERS ON OCHEWITE 2 DO WHEREAS, on October 6, 2016, a Petition was filed with the Forsyth County Board of Commissioners on behalf of Petitioner, Steve Plemmons requesting the closing of a portion of No Name 6 Road, hereinafter described, which property is lying and being within the county limits of Forsyth County; and it appearing to the Forsyth County Board of Commissioners from said Petition that a public hearing should be held on the question of closing the portion of No Name 6 Road, pursuant to authority conferred upon counties by the provisions of N.C.G.S. 153A-241; and

WHEREAS, the Planning and Development Services Department reports that the subject road, No Name 6 Road, has never been maintained by North Carolina Department of Trans-portation, therefore, no abandonment of maintenance is required;

WHEREAS, the Planning and Development Services Department concludes that there would be no negative impacts from the right-of-way being closed since all of the affected properties are owned by the Petitioner: and

WHEREAS, based on said Petition to Close a Portion of No Name 6 Road and the above Planning staff findings, the Forsyth County Board of Commissioners will declare herein its intent to close said portion of No Name 6 Road; and

WHEREAS, the Forsyth County Board of Commissioners will call a public hearing on the Petition to Close a Portion of No Name 6 Road, nothing else appearing for Monday, January 9, 2017 at 2:00 p.m. in the Commissioners' Meeting Room on the fifth floor of the Forsyth County Government Center; and

WHEREAS, pursuant to the provisions of N.C.G.S. 153A-241, the Forsyth County Board of Commissioners will direct the Petitioner to cause notice of the public hearing reasonably calculated to give full and fair disclosure of the proposed road closing to be published once a week for three successive weeks before the hearing date, a copy of this Resolution to be sent by registered or certified mail to each owner as shown on the county tax records of property adjoining the affected por-tion of the public road who did not join in the Petition to Close a Portion of No Name 6 Road, and a notice of the closing and public hearing to be

prominently posted in at least two places along the said portion of No Name 6 Road;

NOW, THEREFORE, BE IT RESOLVED, by the Forsyth County Board of Commissioners as follows:

(1) That the Board of Commissioners hereby declares its intent to close said portion of the No Name 6 Road as described in and pursuant to the provisions of the attached Petition to

(2) That the date and hour fixed for a public hearing on said Petition to Close a Portion of No Name 6 Road is hereby set for Monday, January 9, 2017, at 2:00 p.m., in the Commissioners' Meeting Room on the fifth floor of the Forsyth County Government Center at 201 N. Chestnut Street in Winston-Salem, North Carolina;

(3) That all persons who are interested in the closing of the portion of No Name 6 Road and desiring to be heard, are hereby notified to appear before the Forsyth County Board of Commissioners, at the above-scheduled public hearing, at which time and place they will be heard in favor of or in opposition to the adoption of a resolution ordering the closing of the portion of No Name 6 Road de-scribed as follows: Being that por-tion of the designated "30 FT DRIVE" lying west of and adjacent to Lot Nos. 30, 31, 32, 33, 34, 35, 36, 37, 38 and 39 as depicted on a plat entitled "Map of the G.T. 
