RESOLUTION AUTHORIZING REFUND OF EXCISE TAX OVERPAYMENT UPON THE RECOMMENDATION OF THE COUNTY REVIEW OFFICER (REGISTER OF DEEDS)

WHEREAS, pursuant to the provisions of N.C.G.S. 105-228.37, the Forsyth County Board of Commissioners is required to review any timely request by a taxpayer for a refund of overpayment of excise tax on the conveyance of property and to make a timely decision regarding the County's portion of any overpayment; and

WHEREAS, the Forsyth County Board of Commissioners previously adopted a Resolution authorizing the designation of a County Review Officer on the recommendation of the Register of Deeds to investigate and hear each claim for refund and make a recommendation to the Board of Commissioners regarding such claims; and

WHEREAS, the Forsyth County Register of Deeds received a written request dated March 6, 2018 for refund of the County's portion of a \$204,000.00 excise tax overpayment from Kenneth D. Pack, Jr. of the Office of Hankin & Pack, PLLC, 2820 Selwyn Avenue, Suite 425, Charlotte, N.C. 28209, as a result of a Softpro malfunction which transposed the purchase price and the amount of excise tax when recording a deed in Forsyth County on January 16, 2018; and

WHEREAS, Kenneth D. Pack, Jr. has recorded with the Forsyth County Register of Deeds, a correct Deed and an Affidavit for Refund of Real Estate Excise Tax, which outlines the facts involving the Refund Request, in Book 3394 at Pages 1005 and 1006, respectively; and

WHEREAS, based on the investigation and hearing of the matter, it is the recommendation of the designated County Review Officer that Simplifile LC should be given a refund of the County's portion of the excise tax overpayment in the amount of \$104,040.00, and the Forsyth County Board of Commissioners should authorize a refund of excise tax in that amount, plus any applicable interest; and

WHEREAS, the North Carolina Department of Revenue has agreed that the State's portion of this overpayment in the amount of \$99,960.00 should also be refunded and has authorized Forsyth County to refund the Department's share of the excise tax overpayment to Simplifile LC and has agreed to reimburse the County for the State's share of the refund.

NOW, THEREFORE, BE IT RESOLVED that the Forsyth County Board of Commissioners, based on the investigation, hearing, and recommendation of the County Review Officer, hereby decides that Simplifile LC is entitled to a refund of the County's portion of the above overpayment of excise tax in the amount of \$104,040.00, and also pursuant to agreement by the North Carolina Department of Revenue, the State's portion of the said overpayment of excise tax in the amount of \$99,960.00, for a total refund of \$204,000.00, plus any applicable interest.

BE IT FURTHER RESOLVED that Forsyth County Board of Commissioners hereby authorizes the County Chief Financial Officer to make payment to Simplifile LC in the total amount of \$204,000.00.
