RESOLUTION AUTHORIZING EXECUTION OF A SERVICE AGREEMENT WITH MOTOROLA SOLUTIONS, INC. FOR MAINTENANCE OF THE 800 MHZ COMMUNICATIONS SYSTEM OF THE CITY OF WINSTON-SALEM AND FORSYTH COUNTY (INTERAGENCY COMMUNICATIONS DEPARTMENT)

WHEREAS, the Interlocal Cooperation Agreement for Installation, Operation, and Maintenance of an 800 MHz Trunked Radio System between the City of Winston-Salem and Forsyth County entered into in 2002 provides that the System operation and management will be employed through a County department and that operational and maintenance costs will be shared equally by the City and County for jointly owned property of the System; and

WHEREAS, since the beginning of operation of this 800 MHz Communications System, Motorola Solutions Inc. has been the sole service provider for system maintenance and problem resolution, providing repair solutions only available from Motorola Solutions Inc.;

NOW, THEREFORE, BE IT RESOLVED by the Forsyth County Board of Commissioners that the Chairman or County Manager and Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, a Service Agreement with Motorola Solutions, Inc. in the annual amount of \$383,926.52 for maintenance services on the 800 MHz Communications System of the City of Winston-Salem and Forsyth County, beginning July 1, 2018, and ending June 30, 2019, which cost will be equally shared by the City and the County on jointly owned property, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney. The original contract is incorporated herein by reference (Contract Control #2019-0157-00).

BE IT FURTHER RESOLVED by the Forsyth County Board of Commissioners that the County Manager and the Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, subsequent contracts for these services and amendments thereto within budgeted appropriations in the current and future fiscal years, if these services remain necessary to the County.
