EXPLANATION:

The Forsyth County Public Library has received a donation in support of the Kernersville Branch renovation project.

Mr. H. Pratt Dunlap, Sr. gave a donation of \$15,000. The Tom and Barbara Fulp Fund made a donation of \$2,500. The Kiwanis Club of Kernersville and Friends of Paddison Memorial Branch Library made a donation of \$15,000. The Lawrence E. Pope Foundation made a donation of \$55,000 for the renovation of the Children's Room and Courtyard. The Rotary Club of Kernersville made a cash donation of \$10,000. The Jim & Mary Taylor Fund made a donation of \$25,000 for the renovation of the Teen Space.
