RESOLUTION AUTHORIZING EXECUTION OF NECESSARY DOCUMENTS TO APPLY FOR AND ACCEPT, IF AWARDED, THE HEALTHY BEGINNINGS GRANT THROUGH THE NORTH CAROLINA DEPARTMENT OF HEALTH AND HUMAN SERVICES, DIVISION OF PUBLIC HEALTH, WOMEN'S HEALTH BRANCH (FORSYTH COUNTY DEPARTMENT OF PUBLIC HEALTH)

WHEREAS the North Carolina Department of Health and Human Services, Division of Public Health, Women's Health Branch, released a Request for Application entitled, "Healthy Beginnings";

WHEREAS the request for applications allows local health departments to seek funding at an award ranging between \$65,000 to \$80,000, annually for three years;

WHEREAS the Forsyth County Department of Public Health historically received grant funding and operated the Healthy Beginnings program for the past 20 years; and

WHEREAS the Forsyth County Department of Public Health wishes to continue the Healthy Beginnings program and apply for and accept the grant, if awarded;

NOW, THEREFORE, BE IT RESOLVED, that the Forsyth County Board of Commissioners hereby authorizes the County Manager and Clerk to the Board to execute, on behalf of Forsyth County, the necessary documents to submit a Request for Application for the Healthy Beginnings grant through the North Carolina Department of Health and Human Services, Division of Public Health, Women's Health Branch; and

BE IT FURTHER RESOLVED by the Forsyth County Board of Commissioners that the Chairman or County Manager and Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, necessary documents to receive grant funds, if awarded, from the North Carolina Department of Health and Human Services, Division of Public Health, Women's Health Branch to support the Healthy Beginnings program, subject to a pre-audit certificate thereon, by the Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.
