EXPLANATION:

On December 21, 2018, the Forsyth County Sheriff's Office received notification of eligibility to apply for an award of \$91,077 from the State Criminal Alien Assistance Program (SCAAP). The funds are awarded by the U.S. Department of Justice. The allocated award amount was determined based on the number of eligible incarcerated undocumented criminal aliens and their length of stay from fiscal year 2016-2017.

As per the Department of Justice Reauthorization Act of 2005 (Public Law 109-162, Title XI) SCAAP funds may only be used "for correctional purposes" listed in the award solicitation. Since the original award in 2010, a total of \$676,915 has been received and \$447,851 has been expended. No funds under the SCAAP program have been awarded to any jurisdiction in nearly three (3) years.

The purpose of this Budget Ordinance Amendment is to appropriate the \$91,077 to the Sheriff's Office, Detention Facility Operations. As in previous years, the unspent balance at June 30, 2018 will be re-appropriated in the FY 2019-2020 budget.

BE IT ORDAINED BY THE FORSYTH COUNTY BOARD OF COMMISSIONERS THAT THE FISCAL YEAR 2018-2019 BUDGET ORDINANCE IS HEREBY AMENDED AS FOLLOWS:
