RESOLUTION AUTHORIZING EXECUTION OF A CONTRACT TO PROVIDE LEGAL SERVICES FOR FORECLOSURE ACTIONS ON DELINQUENT REAL PROPERTY ACCOUNTS (FORSYTH COUNTY TAX DEPARTMENT)

WHEREAS the Forsyth County Tax Administration utilizes a foreclosure program to facilitate equity and compliance with the collection of Forsyth County Tax when all other collection efforts available to the Tax Office, through the Machinery Act, have not satisfied the delinquency on real property accounts. The Tax Administration uses the mortgage style foreclosure procedures per N.C.G.S. 105-374, which involves a standard civil action filed in State court;

WHEREAS after due advertisement, a bid was received and publicly opened by the City/County Purchasing Department at 12:00 p.m., on Tuesday, July 2, 2019, for Requests for Proposals (RFP) process to identify Legal Services for foreclosure actions on delinquent real property taxes due to the County;

WHEREAS terms of the bid specifications requested bidders to submit their qualifications, experience, results and pricing for Legal Services for foreclosure processing, allowing the County the opportunity to select the bids that are in the best interests of the County. One bid was received by Mark D. Bardill, P.C. dba Zacchaeus Legal Services; and

WHEREAS following review and evaluation of the bid received, it is the recommendation of the County Manager, Tax Assessor/Collector, and the Purchasing Director that a contract be awarded to the above identified bidder and that the County Manager be authorized to execute contracts, on behalf of Forsyth County;

NOW, THEREFORE, BE IT RESOLVED, by the Forsyth County Board of Commissioners that contracts for Legal Services for foreclosure processing for Forsyth County are hereby awarded to Mark D. Bardill, P.C. dba Zacchaeus Legal Services, with a grand total not to exceed \$336,000 and that all other bids are rejected; and

BE IT FURTHER RESOLVED, that the County Manager and Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, contracts for Foreclosure Legal Services for the Forsyth County Tax Administration, as identified herein with Mark D. Bardill, P.C. dba Zacchaeus Legal Services to provide foreclosure services for consideration by the County.
