RESOLUTION ACCEPTING THE HIGHEST BID TO PURCHASE COUNTY OWNED REAL PROPERTY BY NEGOTIATED OFFER, ADVERTISEMENT, AND UPSET BIDS PROCEDURE – 0 N. GRAHAM AVENUE (GENERAL SERVICES DEPARTMENT)

WHEREAS as a result of a property tax foreclosure proceeding, Forsyth County currently owns real property located at 0 N. Graham Avenue, Winston-Salem, N.C., further identified as Parcel Identification Number 6835-86-2591.00, for which the County has no use for and wishes to sell to the highest bidder;

WHEREAS Forsyth County received an offer in the amount of \$3,648.00 from Mr. Curtis Cazoe to purchase the above-described property and the Clerk to the Board collected a deposit of 5% of the offer from Mr. Curtis Cazoe to purchase County owned real property;

WHEREAS by resolution authorizing publication of an offer to purchase County owned real property by the negotiated offer, advertisement, and upset bids procedure adopted by the Forsyth County Board of Commissioners at its October 10, 2019, meeting, a notice of offer to purchase real property owned by Forsyth County and request for upset bids was advertised as required by N.C.G.S. 160A-269 relating to the above described property;

WHEREAS after due advertisement of said offer, no upset bids have been received within the time allowed by law; and

WHEREAS County staff recommends that the Forsyth County Board of Commissioners accept the original offer and sell the said property to Mr. Curtis Cazoe for \$3,648.00;

NOW, THEREFORE, BE IT RESOLVED, that the Forsyth County Board of Commissioners hereby accepts the offer of the highest bidder, Mr. Curtis Cazoe, in the amount of \$3,648.00, to purchase the above described County owned real property; and

BE IT FURTHER RESOLVED, that the Chairman or County Manager and Clerk to the Board are hereby authorized to execute any necessary documents to complete the sale of the above described property and collect the balance of the purchase price, subject to a pre-audit certificate by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
