WHEREAS the United States Food and Drug Administration has established the Voluntary National Retail Food Regulatory Program Standards;

WHEREAS Forsyth County Department of Public Health, as part of the Voluntary National Retail Food Regulatory Program Standards Grant Program, is eligible for an award of \$2,500 that benefits the Department's Food, Lodging and Institutions Program as it pertains to conducting a second self-assessment related to Federal standards that are administered locally;

WHEREAS funds are available through a grant from the United States Food and Drug Administration, awarded to the Association of Food and Drug Officials (AFDO) to assist local food protection programs in meeting the established program standards; and

WHEREAS the award to Forsyth County Department of Public Health is considered a sub-award under this AFDO grant and Forsyth County Department of Public Health will be reimbursed for conducting a second self-assessment of compliance with Program Standards;

NOW, THEREFORE, BE IT RESOLVED, that the Forsyth County Board of Commissioners hereby authorizes the Chair or County Manager and the Clerk to the Board to execute the necessary documents, on behalf of Forsyth County and its Department of Public Health, to receive \$2,500 grant funds from AFDO with funding provided by the United States Food and Drug Administration, subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
