SUBJECT: AMENDMENT TO THE 2018 MOTIVE EQUIPMENT REPLACEMENT CAPITAL PROJECTS ORDINANCE TO APPROPRIATE INSURANCE PROCEEDS AND GENERAL FUND TRANSFER FOR VEHICLE PURCHASE

COUNTY MANAGER'S RECOMMENDATION OR COMMENTS: Recommend Approval

SUMMARY OF INFORMATION:

Forsyth County has adopted a capital projects ordinance for the replacement of vehicles for various County departments in order to allow user departments to have more responsibility for the efficient purchase of vehicles without the expectation that the funds must be spent within the fiscal year.

The purpose of this CPO amendment serves two purposes. The first purpose is to appropriate \$19,406.15 in insurance proceeds from five (5) separate total loss auto accidents to the Motive Equipment CPO for future vehicle purchases as follows:

- Fleet
 - VID# 2512 -- 2012 Dodge Caravan - \$4,625.00
 - VID# 6097 -- 2007 Chevy Malibu - \$3,609.15
 - VID# 9568 -- 2008 Dodge Avenger - \$2,500.00
 - VID# 1399 -- 2010 Ford Explorer - \$5,397.00
- Sheriff
 - VID# 2402 -- 2012 Dodge Charger - \$3,275.00

The second purpose is to transfer \$16,693.21 from the General Fund for the purpose of purchasing a vehicle for an Environmental Health Supervisor position. These funds are currently in the FY20 Health Department Operating Budget and require transfer into the Motive Equipment CPO before a vehicle may be purchased.
