## FORSYTH COUNTY, NORTH CAROLINA AMENDMENT TO 2018 MOTIVE EQUIPMENT CAPITAL PROJECTS ORDINANCE

FROM: BUDGET & MANAGEMENT MEETING DATE: August 6, 2020

**EXPLANATION:** Forsyth County has established Capital Projects Ordinances (CPO) every other year since 2013 for the replacement of automobiles and mobile equipment for various county departments. The purpose of the CPO is to allow for more responsible and efficient purchasing of vehicles without believing that all funds must be spent within the fiscal year.

The amendment to the 2018 Motive Equipment Replacement CPO transfers remaining funds to the 2020 Motor Vehicles and Mobile Equipment Replacement CPO and closes the 2018 Motive Equipment Replacement CPO.

Adoption of the 2020 Motor Vehicles and Mobile Equipment Replacement CPO appropriates the revenues of \$1,450,000 from the General Fund, \$156,400 from the Sale of Vehicles and Law Enforcement Community Policing Contracts, \$28,963 from insurance/claims proceeds, and the transfer of remaining funds from the 2018 Motive Equipment Replacement CPO in the amount of \$419,648, for the replacement of automobiles and mobile equipment.

Be It Ordained that the following projects are hereby authorized in concept and the following amounts are hereby appropriated for purchase of motive equipment for the following departments, subject to review by the County Manager, compliance with applicable bidding laws, and final award or authorization by the Board of County Commissioners of specific contracts for each project as required by law or the Budget Ordinance; and the County Manager, Clerk to the Board and County Chief Financial Officer are hereby authorized to execute the necessary documents to carry out these purposes, subject to the limitations herein, a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and the approval as to form and legality by the County Attorney.

#### **EXPLANATION:**
