ORDINANCE AMENDING CHAPTER 7 OF THE FORSYTH COUNTY CODE BUILDINGS AND BUILDING REGULATIONS

BE IT ORDAINED by the Board of Commissioners of Forsyth County as follows:

Value

Section 1. Chapter 7, ARTICLE II. BUILDING PERMITS AND INSPECTIONS, Section 7-18, Permit fees generally to be amended as follows:

(a) Permit fees for existing nonresidential construction**. For all existing nonresidential construction, alterations, remodels, repairs, demolitions or expenditures for improvements on existing nonresidential buildings, other than painting, the Inspections Director, or designee, shall charge for each and every building on which permits are granted the following fees for inspections, based on the value of the work, such fees to be paid in advance:

Section 2. Chapter 7, ARTICLE III. PLUMBING PERMITS AND INSPECTIONS, Section 7-39. Inspection fees to be amended as follows:

- (a) Fee schedule. Before a permit shall be granted for the construction or alteration of a plumbing or drainage system, as provided in the plumbing code referred to in section 7-2, the applicant shall pay to the City of Winston-Salem an inspection fee in accordance with the following schedule:

RE: Staff Approach to the Proposed FY2013-14 Fee Amendment

The City of Winston-Salem's Citizen's Organizational Efficiency Review Committee (COERC) recommended an across the board fee increase of 10% for all Inspection Fees. This recommendation was based in part because most of the fees have not been increased since 2004. While we agree with the Committee's need to implement a fee increase, an across the board increase doesn't accurately reflect the needs of the Inspections Division. First, there are many fees that need no adjustment. Second, and most importantly, an across the board fee increase disproportionately impacts the cost of the smaller, more affordable homes and projects (as a percentage of total cost). For this reason, Inspections staff recommends a tiered approach to residential building and trade permits fees, increasing the commercial building permit fee multiplier, and raising the cost of the minimum permit fee.

First, under the tiered approach, the permit fees increase as the square footage of the house increases. Generally speaking, the larger a home becomes, the more complex the systems and building components in the home becomes – increasing the complexity of the necessary inspections. Further, codes covering the more complex systems have more variables; structures require a greater number of inspections and more time per inspection because of size and complexity of the systems and construction methods, and the overall size of the structures leads to the need for lengthy/multiple inspections for the same inspection type. It helps to look at it this way - the proposed fee increase under the tiered approach is a fair and reasonable constant multiplier, which causes the value of the permit to increase as square footage and complexity goes up. Other jurisdictions using the tiered approach include the Town of Kernersville, the City of Greensboro, the City of Raleigh, Iredell County, Charlotte/Mecklenburg Inspections, the City of Goldsboro, New Hanover County and the City of Asheville. Please see Example 1 for a comparison of our current fees and the tiered fee approach in the local market and our peer jurisdictions across the state.

Second, our current fee schedule/multiplier for commercial projects fails to provide for cost recovery for our Construction Control function. While the actual method of calculating commercial fees is too difficult to explain in this memo, the chart on the next page (Example 2) will demonstrate that our current multiplier of 0.54 is well below our local market and our peer jurisdictions across the state. We have provided two (2) different "proposed" multipliers—the 0.66 multiplier represents 100% cost recovery for our Construction Control section, but does not take into account the office functions and zoning plan review/zoning field inspection functions that are essential to the overall success/completion/compliance of a project. The 0.94 multiplier should accomplish 100% cost recovery across all of Inspections.

Finally, our current fee schedule establishes our minimum permit fee cost at a rate much too low to cover the cost of the required inspections. Our current fee schedule allows for building and trades permits to be purchased based on a dollar amount for the project (ex. — any work the building contractor states as being less than \$5000.00 yields a \$45.00 permit) or a fixture count for the trades work being done (ex. — water heater \$10.00, sink \$10.00, etc., yields a \$45 permit). In the last year we issued 452 building permits and 8,204 trade permits for the minimum \$45.00 fee. Over 70% of those permits (over 6000 of them) required at least two on-site inspections by our staff. Dividing department expenses by the number of inspections we make in a year gives us an approximate cost of \$66.00 per inspection. Having made at least two trips for over 70% of the \$45.00 permits indicates that we are providing \$132.00 worth of

service for \$45.00 – this is not an effective or efficient use of our resources. We propose raising the minimum permit fee to \$65.00 to help pay for at least one of the trips on this type of minimum fee permit. Please see **Example 3** below for the minimum fees charged by the local market and our peer jurisdictions across the state.

The above approach has been discussed with the Finance Committee, as well as the Committee of the Whole of the City Council and they have directed staff to bring the proposed amendments forward with the 2013-14 Budget Package.
