# FORSYTH COUNTY, NORTH CAROLINA AMENDMENT TO THE FY2013-2014 BUDGET ORDINANCE

FROM: BUDGET & MANAGEMENT MEETING DATE: December 16, 2013

#### **EXPLANATION:**

The Chief Financial Officer requested the reallocation of the costs of the purchase of the Reynolda Manor Branch Library from the General Fund to the 2014 Reynolda Manor Branch Library Capital Projects Ordinance.

A purchase contract has been fully executed (2014-278) and earnest money has been paid.

This budget ordinance amendment completes two (2) tasks: 1) reduces the capital expenditure in the General Fund for the purchase of the Reynolda Manor Branch Library and transfers it to a newly adopted Reynolda Manor Branch Library Capital Projects Ordinance and 2) reduces the lease amount in the Library's operating budget and transfers the unexpended portion of the lease agreement to the Reynolda Manor Branch Library Capital Projects Ordinance to cover associated sale closing costs and needed repairs.

Once approved, accounting entries by Finance are required to adjust for the earnest money already paid as well as the remaining contract encumbrance.
