SUMMARY OF INFORMATION:

The City of Winston-Salem applied for a grant through The North Carolina Governor's Highway Safety Program (GHSP) to continue the Forsyth County DWI Joint Task Force. The Task Force is manned by three officers and one sergeant from the Winston-Salem Police Department; one deputy from the Forsyth County Sheriff's Office and one officer from the Kernersville Police Department. Each of these officers is assigned exclusively to the Task Force and is responsible for enhanced enforcement of laws prohibiting driving while intoxicated. The Task Force will operate throughout the geographic area of Forsyth County.

The initial grant period was from 10/1/2010 through 9/30/2011, with 100% funding for the designated officers, assigned equipment and vehicles. The fourth year of funding, with a 50% match, is currently in process through September 30, 2014. Originally, each agency was expected to provide full funding for its officers assigned to the DWI Task Force during the fifth year. However, the Governor's Highway Safety Program has offered to provide 25% funding of the DWI Task Force for Year 5, for the time period of October 1, 2014 through September 30, 2015.

Based on this offer, Year 5 will be 25% funded. The maximum financial commitment (match) required by the County of Forsyth in this grant cycle will be \$56,250 (Year 5).

The Winston-Salem Police Department will submit the application to the Governor's Highway Safety Program for Year 5, with the 25% funding.

An Interlocal Agreement and a Mutual Assistance Agreement between Forsyth County, the City of Winston-Salem, and the Town of Kernersville regarding the shared use of the grant funds will be submitted at a future date.

The Sheriff's Office is requesting authority to continue participating in year 5 of the Forsyth County DWI Task Force as funded by the Governor's Highway Safety Program Traffic Safety Project Grant for the period, October 1, 2014 through September 30, 2015, with 25% grant funding.
