RESOLUTION AUTHORIZING SUBMISSION OF THE REVISED FISCAL YEAR 2013-2014 HOME AND COMMUNITY CARE BLOCK GRANT COUNTY FUNDING PLAN FOR OLDER ADULTS TO REDIRECT FUNDS FROM GENERAL TRANSPORTATION TO MEDICAL TRANSPORTATION PROVIDED BY THE WINSTON-SALEM TRANSIT AUTHORITY

WHEREAS, upon the recommendation of the Forsyth County Aging Services Planning Committee, the attached revised 2013-2014 Home and Community Care Block Grant for Older Adults County Funding Plan is submitted to the Forsyth County Board of Commissioners for review and authorization for submission to the North Carolina Department of Health and Human Services, Division of Aging; and

BE IT FURTHER RESOLVED that upon approval of the said revised County Funding Plan, by the North Carolina Department of Health and Human Services, Division of Aging, the Chairman or County Manager and Clerk to the Board are hereby authorized to execute necessary documents, on behalf of Forsyth County, to receive the funds and to implement the activities outlined therein and further to execute an agreement for the provision of County-Based Aging Services with the Piedmont Triad Regional Council as the Area Agency on Aging, subject to approval as to form and legality by the County Attorney and a pre-audit certificate thereon by the Chief Financial Officer, if applicable.
