ORDINANCE NAMING AN UNNAMED DEDICATED PUBLIC ROAD RIGHT OF WAY LOCATED WITHIN THE UNINCORPORATED AREA OF FORSYTH COUNTY, "TABOR LAKE DRIVE" (CITY/COUNTY PLANNING AND DEVELOPMENT SERVICES DEPARTMENT)

WHEREAS, Planning staff requested an unnamed dedicated public road right of way located within the unincorporated area of Forsyth County be named Tabor Lake Drive; and

WHEREAS, the Addressing/Street naming staff of the City/County Planning and Development Services Department received no opposition from the adjoining property owners to the proposed road name; and

WHEREAS, the proposed road naming does not pose any address range or road name duplication issues and has been reviewed and approved by emergency response agencies; and

WHEREAS, pursuant to the provisions of N.C.G.S. 153A-239.1, at least ten (10) days prior to conducting the public hearing to name the said road, Forsyth County caused notice of the time, place, and subject matter of the hearing on this proposed road naming to be prominently posted at the Forsyth County Courthouse and in at least two public places in the township or townships where the road is located, and to be published in a newspaper of general circulation published in Forsyth County.

NOW, THEREFORE, BE IT ORDAINED by the Forsyth County Board of Commissioners after providing notice and conducting a public hearing as required by law, that the unnamed dedicated public road right of way located within the unincorporated area of Forsyth County, as further identified on the attached map, is hereby named Tabor Lake Drive.

BE IT FURTHER ORDAINED that after naming Tabor Lake Drive, Forsyth County shall cause notice of this action to be given to the local Postmaster with jurisdiction over the said road, to the N.C. Board of Transportation, and to any municipality within five miles of the said road as required by law.

BE IT FURTHER ORDAINED that this Ordinance shall become effective upon its adoption.




To name a road Tabor Lake Drive

Staff Recommendation – Renaming Morris Rd to Tabor Ranch Rd and Naming Tabor Lake Dr

The North Carolina Department of Transportation has begun construction of the Beltway which has created 2 separate segments of Morris Road. The short segment that extends off Wrangler Dr was proposed to be renamed to Wrangler Ln in a 30-day comment period letter. During the comment period, the Tabors contacted me to propose a different street name, Tabor Ranch Rd. They also proposed naming an unnamed public right-of-way that extends north off Wrangler Dr, 1400 feet west of Morris Rd to Tabor Lake Dr. Both of these street names were approved by E911 agencies and petitions were submitted to show the adjoining property owners in favor of these 2 street names. Staff recommends approval of these 2 proposed street names.
